(3) of Law 24/2017 on issuers of financial instruments and market operations, republished, in conjunction with the provisions of art. 117<sup>1</sup> of Corporations Law no 31/1990, republished with later amendments and additions, has requested that the agenda of the Shareholders' General Extraordinary Assembly convened for the date of 12/13.08.2024, 10:00h in Bucharest, 3 district, Olteni street no.2-4, "PLATINUM Center" building, 11th floor, meeting room no. 1112, for all shareholders registered at the end of day of August 2, 2024 in the Register of the Company's Shareholders, firstly published in the Official Gazette of Romania part IV, no. 3379/11.07.2024 and in Adevarul newspaper on 11.07.2023, shall be completed with the following item:

We also inform that based on art. 105 para.
