Financial results for the period January-September 2020

CONPET SA recorded, in the first 9 months of 2020 a turnover of 304.01 million RON, decreasing

by 0.1% as compared to the same period of the previous year and increasing by 0.5% as compared

to the budgetary provisions.

The net profit achieved during January-September 2020, of 48.95 mRON is increasing by 6.21

mRON (14.5%) as compared to the budget provisions and decreasing by 1.13 mRON (2.3%) YoY.

At 30.09.2020, the operating revenues recorded an increase by 1.3% as compared to 9 months 2019

(334.37 mRON: 9 months 2020 from 329.99 mRON: 9 months 2019), due to increase of transport

revenues by 0.6% (300.98 mRON 9 months 2020 from 299.20 mRON 9 months 2019). As compared

to the budget provisions, the operating revenues increased by 0.4%.

The operating expenses achieved in 9 months 2020 recorded an increase by 1.9% as compared to

the same period in 2019 (9 months 2020: 281.86 mRON, 9 months 2019: 276.49 mRON) mainly

due to the increase in the costs of transport of crude oil by rail and the modernization quota formed

as a source of financing investments in the public domain.

As compared to the budget, the operating expenses are 1.6% below the budgeted level.

The operating profit achieved at 30.09.2020, as compared to the same period of 2019 has recorded

a decrease by 0.98 mRON (1.8%).

EBITDA records a value by 1.45 mRON (1.6%) higher than the one achieved in the previous year.

As compared to the budgetary provisions, the operating profit is increasing by 5.98 mRON (12.8%)

and the achievement of EBITDA is of 7.0%.
